Meaning and definition of ragging

The university is committed to ensure that their experience here will be enriching, positive and free from any form of harassment. The Supreme Court defined ragging in the Vishwa Jagriti matter (1999) as, "Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

COMPLAINT FORM FOR ANTI-RAGGING

3. Instructions against ragging

We take pride in informing all those desirous of seeking admission, that over all these years, our University has the best traditions of maintaining a healthy and congenial academic environment. We are also glad to convey that with the determined and sincere efforts of our senior students and faculty, our campus has been free from the menace of Ragging.

What constitutes Ragging?

Instructions against Ragging:

Ragging constitutes one or more of any of the following acts:

(a) any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.

(b) indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.

(c) asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.

(d) any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.

(e) exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.

(f) any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

(g) any act of physical abuse including all variants of it: sexual abuse, homosexual assaults,

stripping, forcing absence and lewd acts, gestures, causing bodily harm or any other danger to health or person.

(h) any act or abuse by spoken words, e-mails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.

(i) any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

Punishment Provisions:

Any student or group of students found guilty of ragging on campus or off-campus shall be liable to one or more of the following punishments.

- Debarring from appearing in any sessional test/ university examination or withholding result.
- Suspension from attending classes and academic privilege.
- Withdrawing scholarships and other benefit.
- Suspension from the university for a period of one month.
- Cancellation of admission.
- Debarring from representing the institution in any national or international meet,

tournament, youth festival, etc. Suspension/expulsion from the hostel.

- Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period.
- Expulsion from the institution and consequent debarring from admission to


any other institution Fine up to twenty five thousand rupees.

• Imprisonment for a term which may extend to two years or with fine which

may extend to ten thousand rupees or with both

Collective Punishment - When the students committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
